2. Performance Highlights

- In comparison to May 2024, the company has demonstrated significant year-on-year growth across all key operational metrics for May 2025. The number of clients billed increased from 11 to 14, marking a growth of 27.27%, while the number of locations billed rose from 21 to 29, reflecting an impressive 38.10% increase. This expansion in client base and service coverage has contributed to a notable 26.79% increase in total revenue, which rose from ₹3.36 crore to ₹4.26 crore. Additionally, the company has expanded its geographical footprint, now operating in 10 cities as compared to 5 cities in the same period last year. This growth highlights the company's continued focus on market expansion, client acquisition, and revenue enhancement.
- Our revenue grew marginally from ₹4.23 crore to ₹4.26 crore, reflecting a 0.71% increase on a month-on-month basis, despite no addition in the number of clients or client locations. This growth can be attributed to higher utilization levels and improved service uptake by existing clients, especially in segments involving value-added services such as air-conditioned vehicle deployments and extended operational hours. The steady performance amidst a static client base indicates strong client retention and incremental revenue opportunities from existing accounts, demonstrating continued confidence in our services.
