While volume growth outpaced revenue growth, the expanded client base, locations, and cities provide a strong foundation for improved monetization and revenue optimization going forward.

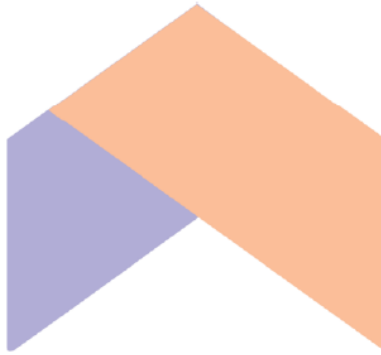
